

Alive & Kicking Poll of MPs

Methodology: CommunicateResearch surveyed 154 MPs on its Parliamentary Panel between 7th and 24th June 2005, on behalf of Alive & Kicking. 80 Labour MPs, 51 Conservatives and 23 MPs from the smaller parties took part. Data were weighted to reflect the precise composition of the House of Commons in terms of party and constituency region.

Q1. The current abortion limit is 24 weeks, except in the case of serious threat to the mother's health or life, or substantial risk of severe physical or mental disability in the foetus, in which case abortion is legal up to birth.
