



September 2011 Armed Forces Survey – Summary of Key Findings

Online fieldwork: 14th – 15th September

Coroners investigate all deaths not clearly resulting from natural causes. A Chief Coroner would be a named person, independent of the Government who would lead reform and have the power to raise the standard for how bereaved families, including bereaved Armed Forces families, find out about how their loved ones died. Bereaved Armed Forces families are those who have suffered the loss of a family member in the service of the armed forces. The investigations into the deaths of Service personnel are called 'Military Inquests'.
